The following provisions shall apply for the artist or art student:

1. The Institute for Plastination (hereafter referred to as "IfP") shall grant the artist/art student, upon presentation of a valid I.D. and/or student card, the permission to make drawings, sketches and paintings (hereafter referred to as "works") in the aforementioned exhibition. The works are to be used exclusively in private context. Any other use of the works, such as book illustrations, advertising activities, Internet pages, in art galleries or any other commercial purposes shall be subject to the prior written consent of the IfP.
2. Creating works in the exhibition is only permitted when exhibition's visitor numbers allow it (not more than 400 people max. in the exhibition at the same time). No easels are allowed inside the building without prior permission.
3. If visitor numbers increase and waiting lines are expected while artist is working, the exhibit organizers have the right to terminate the sketching/drawing.
4. The signatory undertakes to send, free of charge, copies or photos of the sketches/drawings to the BODY WORLDS 3 press office, California Science Center, 700 State Drive, Los Angeles, CA 90037 within two weeks of the artists visit.
5. The IfP leaves it at the artists discretion to present prints of his/her works and to conclude a separate agreement with the IfP, should the IfP be interested in using these prints. Irrespective of these provisions, the IfP requests every artist to provide the IfP with prints which will be used exclusively for internal documentation purposes.
6. Should the artist fail to comply with this agreement, he/she shall undertake to pay a contractual penalty of US \$5,000, to the IfP. This contractual penalty will fall due even if the IfP should ascertain at a later point in time that information which the artist provided was incorrect.
7. The artist/art student/visitor understands that there will be live nude models on display for the purposes of this event.
